REPORT OF FACTUAL FINDINGS TO THE MANAGEMENT BOARD OF THE HONG KONG GIRL GUIDES ASSOCIATION (the "Association")

Pursuant to the agreement dated 8 April 2016 with reference number HAB/CA1/7-5/2(2016-17)(248) made between the Commission on Youth and The Hong Kong Girl Guides Association, we have performed the agreed upon procedures in reviewing whether the Association has complied with, in all material aspects, the requirements set by the of the Association's project which was held from 24 July 2016 (Commencement date) to 31 July 2016 (Completion date) on page 3 to 4 (the "Project Accounts"), and all the terms and conditions as specified in the following documents:

Our engagement was conducted in accordance with the Hong Kong Standard on Related Services 4400 "Engagements to Perform Agreed-upon Procedures Regarding Financial Information" issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA").
